

SuperStream Sign-up Form v1

BBS Accounting is fully compliant with the SuperStream requirements prescribed by the Australian Taxation Office for the reporting and payment of superannuation to superannuation funds. It is a requirement that superannuation is reported via SuperStream either via a software solution or a clearing house, and this can be facilitated directly from BBS Accounting.

Bespoke Business Software utilises a third-party sending software provider (OZEDI) to validate and transmit SuperStream data from BBS Accounting through to the ATO. This service incurs a monthly cost as well as a cost per employee per submission. Should you decide to opt for the automatic payment method, whereby OZEDI can direct debit the funds for superannuation funds from your nominated bank account and distribute it to the super funds on your behalf, there is also a per charge per direct debit.
